The CARSI Initiative, one of the largest and most sophisticated multi-lateral security efforts in the world, provides funding for the USG to assist the governments of the CARSI countries with police professionalization, justice sector reform, counter narcotics efforts, border security management, crime and violence prevention, and anti-corruption efforts.

Duties and Responsibilities

- The Corrections Case Processing Liaison will assist the INL-Guatemala Correction Program Manager with planning, coordinating and implementing complex and multi-faceted strategies to help the GPS and SSW alleviate the prison overpopulation crisis by processing all cases that are eligible for early release and full-term release from GPS and SSW. The Corrections Program Case Processing Liaison will:
- Assist INL-Guatemala Corrections Program Advisor in developing strategic planning sessions and implementation plan to reduce the overpopulation of facilities in GPS and SSW.
- Conduct an analysis of the overpopulation crisis and develop individualized work plans for GPS and SSW.
- Assist INL-Guatemala Corrections Program Advisor in planning work projects and training for case processing staff to reduce over-population in GPS and SSW.
- Assist INL-Guatemala Corrections Program Advisor in advising case processing staff to develop
 and implement specific policy and permanent procedures to follow in order to reduce
 overpopulation of facilities in GPS and SSW via early and full-term release of prisoners.
- Assist INL-Guatemala Corrections Program Advisor to identify Guatemalan law in regard to judicial procedures, requirements, and eligibility for the early and full-term release of prisoners.
- Assist the INL-Guatemala Corrections Program Advisor with implementing USG support to the GPS, which houses adult prisoners, and the SSW which houses juvenile prisoners. in expanding the institution's ability to provide a safe, secure, humane and transparent correctional management system that upholds human rights.
- Provide case processing information from GPS and SSW; analyze and synthesize the information into the form of records, reports, miscellaneous communications, case files, and other sources to support expedited case processing.
- Apply highly developed legal and sentencing expertise to provide a proactive and strategic approach to GPS and SSW overpopulation.
- Establish relationships in the host country as needed to ensure success of case processing reform efforts.
- Perform other duties as assigned.
- Hours for this full-time position will be the core hours of U.S. Embassy Guatemala: 7:30 am to 5:00 pm Monday through Friday, 40 hours per week.
- The position is located in Guatemala City, Guatemala.
- Travel is required.
