The CARSI Initiative, one of the largest and most sophisticated multi-lateral security efforts in the world, provides funding for the USG to assist the governments of the CARSI countries with police professionalization, justice sector reform, counter narcotics efforts, border security management, crime and violence prevention, and anti-corruption efforts.

Duties and Responsibilities

- Provide technical assistance in the drafting of inter and intra institutional protocols and guidelines regarding the implementation of the seized assets law.
- Provide class room training for new appointed personnel on the asset seizure law and implementing regulations.
- Conduct on-the-job advising and direct consultation with legal and law enforcement professionals working on asset forfeiture cases, when required by the Public Ministry, investigators or Judiciary, and in compliance with terms of Guatemalan law.
- Provide guidance and training on the use of the Seized Assets Prosecution Manual.
- Provide follow up to the train-the-trainer (on Seized Assets) project in order improve their capabilities and to promote the training thru certified trainers on the Public Ministry, Judicial Studies School and/or Courts.
- Prepare a concise written report (in Spanish) for the Program Manager upon completion of training, indicating the degree of accomplishment of goals.
- Prepare summary status reports for the Program Manager on a monthly basis to inform INL of the progress of the training and any challenges that require a change in scope or focus of technical assistance.
- Provide technical advice in the design, planning and implementation of INL Rule of Law and Justice Sector Reform projects and activities, including but not limited to, participating in evaluation mechanisms.
- Perform other duties as requested and assigned by INL Rule of Law and Justice Sector Reform Program Manager.
- Hours for contract will be INL Guatemala core hours, with no more than 40 hours maximum per week.
- The position is located in Guatemala City, Guatemala. In-country travel may be required Qualifications
 - A University Law Degree with graduate studies in criminal or constitutional law.
 - Guatemala Citizen
 - RSO security clearance
 - FSI level 4/4 Spanish, Level 3/3 English
 - Demonstrated knowledge of the Guatemalan Asset Seizure Law.
 - Experience as trainer on seized assets and ability to provide expert rule of law subject matter and policy guidance relevant to asset seizure.
 - Familiarized with the implementation of asset forfeiture procedures among judges,





prosecutors and analysts.

- A minimum of 13 years' experience working with justice sector institutions.
- Teaching experience, preferably at the university level and/or to judicial audiences and high and medium rank Guatemalan professionals.
- Ability to conduct training and evaluation in Spanish, which will require the ability to speak, write, and read Spanish (Level V).
- Ability to communicate complex issues in Spanish, both orally and in written form.

Preferred Qualifications

- Experience in the application of the Asset Seizure Law.
- Experience working with and building consensus among high-level contacts within the host government.
