- Plan, coordinate, and conduct the training project for treatment center directors and counselors in order to implement a therapeutic model.
- Analyze and revise the 2016 Evaluation of Treatment Centers and write a report with recommendations for the creation of mechanisms for the effective classification and ranking of treatment centers.
- Analyze and submit recommendations for the legalization by ministerial order of the 2015 Minimum Treatment Guide by the Minister of Health.
- Provide technical advice to the Technical Advisor of Treatment Centers for the effective supervision of treatment centers and treatment projects.
- Plan, coordinate, and execute the evaluation and monitoring process of the community drug prevention project and its drug prevention advisors.
